WAIVER (PART 1)

**PLEASE CAREFULLY READ THIS WAIVER AGREEMENT. BY SIGNING THIS WAIVER AGREEMENT, YOU WILL WAIVE CERTAIN LEGAL RIGHTS.**  
Everyone 18 years of age or over must sign this waiver agreement ("Agreement") to participate in the Event (as defined below). Those under 18 years of age must have this Agreement accepted by their parent or legal guardian.

**DEFINITIONS**  
In this Agreement, the following terms have the following meanings: (a) "CHEO" means the Children's Hospital of Eastern Ontario; (b) "Event" means the "CHEO's RBC Race for the Kids" event and all related events and/or activities in connection therewith; (c) "Releasees" means collectively, the CHEO Foundation, CHEO, Royal Bank of Canada and its affiliates, their respective parents, subsidiaries and related entities, any other individual(s) or entity(ies) involved in the development, production, implementation, administration or fulfillment of the Event, and each of their respective directors, officers, administrators, legal representatives, employees, volunteers, agents, successors and assigns; and (d) "Terrain" means any area, land or facilities used in connection with the Event.

**ASSUMPTION OF RISKS**  
I am aware that my participation in the Event involves many risks, dangers and hazards, including, but not limited to: walking, running, biking, observing; changing weather conditions, exposed rock, earth, and other natural objects, trees, tree wells, tree stumps, forest dead fall; changes or variations in the Terrain, which may create blind spots or areas of reduced visibility, exposed holes in the Terrain; impact or collision with fences, vehicles, other participants, volunteers or observers, objects or equipment used in connection with the Event, impact or collision with other participants, spectators, course officials; the failure to participate safely or within my own ability or within designated areas; negligence of other participants or volunteers and negligence on the part of the Releasees. I am also aware that the risks, dangers and hazards referred to above exist throughout the duration of the Event and throughout the Terrain (and that many risks, dangers and hazards are unmarked). I understand that the risks, dangers and hazards described above can lead to loss, harm, damage, injury, cost or expense, including, without limitation, property damage, personal injuries (including, but not limited to, sprains, strains, fractures and/or dislocations, lesions, abrasions, heart attack, head and brain injuries, permanent paralysis and other injuries) and/or death.

I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THIS EVENT AND I FREELY AND VOLUNTARILY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR OTHER LOSS OR EXPENSE RESULTING THEREFROM.

**REPRESENTATIONS AND WARRANTIES**  
I hereby represent and warrant that:

- I will participate in the Event only with the maximum attention to safety and enjoyment of the Event, will act in a manner that protects the health and safety of myself and others, and will not act recklessly or cause any damage while participating in the Event;
- I will maintain my behaviour in accordance with all applicable laws and generally accepted social practices in connection with my participation in the Event, and will abide by any Event safety policies, rules and/or regulations that the Releasees may impose; and
- I am in good health and have no physical condition that would prevent me from participating in the Event or present risk to me in doing so, and I will not participate in the Event if I am in any way under the influence of alcohol or any other substance which inhibits my ability to participate safely.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY

I hereby agree as follows:

- TO WAIVE ANY AND ALL CLAIMS WHATSOEVER THAT I (AND ANY OF MY HEIRS, EXECUTORS, ADMINISTRATORS, PERSONAL REPRESENTATIVES, SUCCESSORS AND ASSIGNS) HAVE OR MAY IN THE FUTURE HAVE AGAINST THE RELEASEES, AND TO RELEASE THE RELEASEES FROM ANY AND ALL LIABILITY FOR ANY LOSS, HARM, DAMAGE, COST, EXPENSE OR INJURY, INCLUDING, WITHOUT LIMITATION, PROPERTY DAMAGE, PERSONAL INJURY AND/OR DEATH, THAT I MAY SUFFER, OR THAT MY NEXT OF KIN MAY SUFFER AS A RESULT OF MY PARTICIPATION IN THE EVENT, DUE TO ANY CAUSE WHATSOEVER, INCLUDING, WITHOUT LIMITATION, FORESEEABLE OR UNFORESEEABLE HUMAN ERROR, NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS' LIABILITY ACT (ONTARIO) ON THE PART OF THE RELEASEES, AND INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF THE EVENT REFERRED TO ABOVE; AND
- TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES FROM ANY AND ALL LIABILITY, CLAIM OR LOSS OF ANY KIND, INCLUDING, WITHOUT LIMITATION, ANY PROPERTY DAMAGE, PERSONAL INJURY AND/OR DEATH TO ANY THIRD PARTY, RESULTING FROM MY PARTICIPATION IN THE EVENT.

CONSENT TO USE PARTICIPANT SOCIAL MEDIA POSTS

In the event the participant chooses to post photos, videos and other information about CHEO's RBC Race for the Kids to a social media platform and identifies the post with the hashtag **#RBCRacefortheKids**, or otherwise voluntarily submits to Royal Bank of Canada or any of its affiliates (together, "RBC") any photos, videos and/or other mementos of any participant taking part in CHEO's RBC Race for the Kids, the participant understands and agrees that RBC may in turn feature such content on the RBC Race for the Kids official website without any compensation or attribution to participant, and RBC may use, edit and publish this content to promote the RBC Race for the Kids after it has taken place on any form of media, including print, online, digital and social media, at any time and throughout the world, in perpetuity, in RBC's discretion (which means RBC processes your data for RBC's legitimate business interest to promote its fundraising work).

DISCLOSE PARTICIPANT CONNECTION

Each time the participant who is an RBC employee shares their story or photos using **#RBCRacefortheKids** in any social media post, the participant must also use **#RBCEmployee** to identify themselves as an employee. If the participant is a family member of an RBC employee and shares their story or photos using **#RBCRacefortheKids** in any social media post, the participant must use **#RBCEmployeeFamilyMember** to identify themselves as a family member of an RBC employee.

LICENSE

The participant grants to RBC the exclusive, unlimited, worldwide, sublicensable right and license throughout the world to republish, reuse, edit any text, audio, video or images in connection with CHEO's RBC Race for the Kids made available by participant to RBC by way of social media post, photos, interviews or otherwise as well as the participant's name, likeness, image, voice, video or other means of identification of the participant (including times and results) in all current and future media (including without limitation, print, audio, visual, audio-visual, virtual media, the Internet, mobile telephony and so-called "3-G" technologies, CD-ROM or DVDs) to be used by RBC for promotional purposes.

RBC PRIVACY STATEMENT

If any provision of this Agreement is found to be illegal, invalid or unenforceable, such illegality, invalidity or unenforceability shall not render the balance of this Agreement illegal, invalid or unenforceable.

In entering into this Agreement, I am not relying on any oral or written representations or statements made by the Releasees with respect to the safety of the Event, other than what is expressly set out in this Agreement. I acknowledge and agree that the Releasees have not made any warranties, guarantees or representations about the state or condition of the Event or Terrain, my safety while participating in the Event, or the results resulting therefrom.

In consideration of the Releasees accepting my application to participate in this Event and permitting my use of the Terrain, and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I confirm that I have read, understood and agree to be legally bound by the terms of this Agreement. I am aware that by signing this Agreement I am waiving certain legal rights, which I or my heirs, next of kin, executors, administrators, assigns, successors and representatives may have against the Releasees.
